The Sonesta Resort is located at 130 Shipyard Drive, Hilton Head Island, South Carolina. Group reservations for the meeting can only be made for registered seminar attendees. Guaranteed reservations must be accompanied by a major credit card. The Sonesta will not hold any reservations unless secured by one of the above methods. The room rate at the Sonesta for standard view rooms is \$259.00/night plus tax (single or double occupancy) and a \$15.00/night resort fee. Getting There

You can fly into the Hilton Head airport (HHH) or the Savannah/Hilton Head Airport (SAV). The Hilton Head airport is approximately 20 minutes from the Sonesta, and the Savannah/Hilton Head Airport is approximately 1 hour from the Sonesta.
